Location

St Martin's Courtyard is located a short walk from Covent Garden and Leicester Square tube stations, just off Long Acre. Adjacent retailers include **Pretty Ballerinas**, with **& Other Stories**, **The White Company**, **Cos** and **Eileen Fisher** and **Barbour** close by.

Significant development has taken place recently including improvements to entrances, public spaces, and new enhanced restaurants with outside terraces overlooking the central retail area.
